4. The provision of personal data is voluntary, but is a prerequisite for participation in the Contest.
5. The data subject has the right to withdraw consent at any time. However, the withdrawal of consent will not affect processing carried out on the basis of that person's consent prior to its withdrawal;
6. Personal data will be kept for the period necessary to fulfil the purposes of the processing indicated in point 3.
